**e. Road Commissioner:** One side of the guard rails is repaired Huntington Bridge- Snow Plow Contract side. Will come back and fix the Town side once work slows down if we don't get someone else to repair it first. The work underneath is completed it is prime and ready to be painted. The remaining steel work also needs to be scrapped and painted. Bean will leave the staging up for a short period for the Town to find someone to paint it. The person he had in mind doesn't have time to do it.

**f. Town Manager:** Looked into the grant information talked to the Corrina Town Manager they did not receive the Grant from Goldman's office they were put on a list to receive the information when it comes out, we are now on that list. The stream grant they did receive 2 out of the 44 given out there was 45 applications. It cost

Corrina approximately \$17,000 for each grant I have the name of their grant writer now. It is opening up again in August. We do have the money in the account if you would like to go this route.

Did over 70 registrations last week, 58 of them could of have been done on line

**Item 6. Old Business:**

- a. **Premium Choice Broadband- Bill Varney-** spoke to the Board in having the Town partner with Premium Choice Broadband in supporting the upgrading of the broadband in Bradford through the ARPA funds. A grant the Town may receive from the State and it has limited spending rules. Looking on the web site it is looking that Bradford could receive \$120,000. This upgrade would cover 39 miles of line work in Bradford. If poles and wires are not up to code they need to be replaced. This upgrade should affect the majority of the residents of Bradford. Those it won't reach are people off the grid or those that live a distance into the woods. They continue to apply for grants and invest into the project. They are looking for a letter of support. **Motion made** by Selectman S. Saunders and 2<sup>nd</sup> by Selectman C. Oakes to have the Town Manager to create a letter in supporting the partnership of investing in to the updating of Bradford's broadband through the ARPA funds.
